Required documents for flooring

As a manufacturer of flooring your are required to provide accompanying commercial documents (ACD) and declaration of performance (DOP) outlining the performance of your cladding.

The untreated ACD and DOP needs the species, density, grade, durability class changing.

The treated ACD and DOP need the above + the preservative used, penetration rate and retention value adding.

Flooring should be ordered and treated to a minimum of Use Class 1 for dry upper floors (insect only) and Use Class 2 (insect and fungi) for floors with a risk of wetting and ground floors.

Note: NPD means No Product Declaration.
