4.2 Most important symptoms and effects, both acute and delayed

Body protection

: Personnel should wear antistatic clothing made of natural fibres or of hightemperature-resistant synthetic fibres.

Other skin protection

Appropriate footwear and any additional skin protection measures should be selected based on the task being performed and the risks involved and should be approved by a specialist before handling this product.
