DIRECTIONS FOR USE

Spread **SANTRAX PATINATION OIL** onto the entire area to be covered. Apply with a soft cloth or brush, horizontally from one end of the surface to the other, NOT in a circular motion. An area of approximately 60 m² will be covered by use of 1 litre or product. Do not allow product to spill onto bituminous felt.

PRECAUTIONS IN USE

SANTRAX PATINATION OIL may be fatal if swallowed and enters airways. May cause drowsiness or dizziness. Toxic to aquatic life with long lasting effects. Repeated exposure may cause dryness or cracking. Keep out of reach of children. Wear protective gloves/protective clothing/eye protection/face protection.
