## DIRECTIONS FOR USE

For light-to-medium-duty cleaning and deodorising, dilute between 20 and 50 ml of **SANTRAX PINE DISINFECTANT** to 1 litre with water.

For disinfecting, dilute 20 ml of product to 1 litre with water.
